

Terms and Conditions

Mother's Day 2026 Competition - North Adelaide Village

1. Introduction

- The Mother's Day competition commences at 4:30pm (CST) on Monday 4 May 2026 and concludes at 10:00am (CST) Monday 11 May 2026.

- All entrants will be subject to and will need to adhere to the terms and conditions as set out by the Promoter and any future terms and conditions or alteration to these terms and conditions.
- To enter the competition, entrants must click on the entry link found on the North Adelaide Village Facebook Page and fill out the online form.
