By entering this competition, participants agree to be bound by these terms and conditions.

1. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is the manager of the North Adelaide Village, Greenpool Management Co Pty Ltd ACN 646 523 122 of C/-: 67 O'Connell Street, North Adelaide, WA 5006. ("**Promoter**").
3. Entry is only open to SA residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, North Adelaide Village, tenants, and their employees (and their immediate families) and agencies associated with this promotion are ineligible to enter. 8. One comment on the Promotional post is considered an entry, given conditions 6.a. and 6.b. are met. Multiple entries are permitted given the Entrant tags different, valid Instagram accounts in each comment.
